## Storm Drain Markers

Storm drain markers (see photos) discussed in the April 2008 issue of Tidings were installed in the Lake Merritt area and other locations throughout the Peralta and Sausal Creek watersheds on September 20, 2008, in an effort coordinated to coincide with Creek to Bay Day. In the Lake Merritt area, five teams installed the metal markers at 49 storm drains around the Lake. These markers were installed as a follow-up to the success of a pilot test installation of the markers on September 15, 2007.

Many people are not aware that the storm drain system and sewer system are not connected.

Water flowing through the storm drain system is not treated before it gets discharged. The warning (“No Dumping, Drains to Bay”) on the storm drain markers is a reminder to residents of the area and visitors that pollutants (e.g., litter, motor oil, car wash runoff) should be kept out of the drains to prevent them from being transported to creeks, Lake Merritt, and San Francisco Bay. Non-point source pollution from dumping and illegal discharges is the primary source of water pollution in California.

At the Lake, 158 volunteers arrived to help in the cleanup effort including an estimated 70 volunteers from Civicorps Elementary School.

The volunteers helped remove litter along the Lake and clean aeration fountains fouled by barnacles, mussels, clams, etc. The work of the participants resulted in the cleaning of approximately 3.4 miles of path surrounding Lake Merritt. Over 205 pounds of litter were removed including thirty bags of trash and one bag of recyclable materials.

The Creek to Bay Day cleanup helped supplement the ongoing work of volunteers at the Lake. By removing the trash from the Lake, not only is the beauty of the Lake enhanced but there is the added benefit of preventing the trash from moving downstream to San Francisco Bay and the ocean.
